2. ACTIVITIES

AMARILE develops software solutions dedicated to reservoir engineering. AMARILE publishes the WEBSITE in order to present and provide to its customers AMARILE products and services.

AMARILE may post all information which could be relevant for its activities.

All pieces of information must be construed as general information and AMARILE cannot and does not warrant the accuracy, correctness or exhaustive character of such information. The USER assumes all risks regarding the interpretation or the use of information published on the WEBSITE.

3. PROHIBITED USER ACTIVITIES

The USER is prohibited from violating, or attempting to violate, the security of the WEBSITE. Any such violations may result in criminal and/or civil penalties against the USER. AMARILE will investigate any alleged or suspected violations, and if a criminal violation is suspected, AMARILE will cooperate with law enforcement agencies in their investigations. Modification

6. PERSONAL DATA PROTECTION

The TERMS OF USE and AMARILE abide by the French Law N°78-17 "Informatique et Libertés" (January 6th 1978), amended by the decree n° 2019-536 (enforced on June 1st 2019) in compliance with the EU General Data Protection Regulation.

AMARILE may collect personal information from the USER through the WEBSITE, in relation to the creation of the AMARILE Account or any requests sent via the WEBSITE. AMARILE may use the personal information provided by the USER in accordance with this Personal Data Protection paragraph and may include it in further contents in order to improve the AMARILE products and services.

AMARILE's precautions to safeguard any personal information provided by the USER against theft, misuse, loss, unauthorized access or disclosure include physical and technical measures. Amarile makes following security provisions:

- a/ AMARILE employees and management are aware of the Personal Data Protection policy which has been communicated to them.

7. COOKIES
